TIP PRESENTED SIX WEBINARS, THREE OF WHICH WERE CONDUCTED FOR THE DEPARTMENT OF STATE HEALTH SERVICES ON TOPICS THAT INCLUDED VACCINE HESITANCY AND STRATEGIES TO IMPROVE VACCINE RATES, CONTINUING EDUCATION FOR COMMUNITY HEALTH WORKERS, AND 85TH LEGISLATION SESSION WRAP-UP. 200 COALITION TOOLKIT HARD COPIES WERE DISTRIBUTED TO 14 IMMUNIZATION COALITIONS ACROSS TEXAS.
